

Plans are being made to provide an entertaining programme of events at Turweston on Saturday 29 September 2012, culminating in the LAA Annual General Meeting at 2.45pm (see details below).

The LAA Shop, with its wide range of books, charts and branded merchandise, will be open until the commencement of the AGM. Although times and details have vet to be finalised, after lunch there will be a presentation on flying with the Battle of Britain Memorial Flight by Squadron Leader Stuart Reid BSc MCGI RAF, who was a Lancaster and Dakota pilot on the Flight for 11 years until his retirement in 2011. Stuart joined the RAF as a Birmingham University Air Squadron Cadet Pilot in 1975 while at the University of Aston in Birmingham. Following RAF pilot training he went on to fly the Jaguar GR1 and the Tornado GR1 at RAF Bruggen in what was then West Germany. He returned to the UK in 1987 to be

an Advanced Flying Instructor on the Hawk T1 at RAF Valley on Anglesey in North Wales, from where he was selected for an Exchange Appointment with the United States Air Force at Randolph Air Force Base in San Antonio, Texas, training USAF Instructor Pilots. He returned to Germany and the Tornado GR1 with 14 Squadron in 1992 and in 1996, following a short staff assignment, was posted to fly the E-3D Sentry, or AWACS, at RAF Waddington in Lincolnshire. While at RAF Waddington in 1999, he joined the Royal Air Force Battle of Britain Memorial Flight (RAFBBMF), becoming 'Bomber Leader' in 2001.

For his final two years of RAF service he flew the HS125 Dominie T1 with 55(R) Squadron at RAF Cranwell training RAF 'Rear crew'. He retired having completed some 35 years' service as a pilot.
